Dr. Gregor Fitz

He obtained his Master degree in Philosophy and Literature at the University of Florence in 1992; after he moved to Bielefeld, Germany, where he got his PhD in Sociology. Before returning to the University of Florence for research reasons in 2003, he had a contract as an Assistant Professor at the Institute of Sociology in Heidelberg (2000/11-2003). Since 2008 he works at the Institute of Sociology of Potsdam as an habilitation candidate.

Recent books and publications include: Max Weber zur Einführung (2008), Max Webers politisches Denken (2004). Soziale Erfahrung und Lebensphilosophie. Georg Simmels Beziehung zu Henri Bergson, (2002) (with Claudia Portioli) Georg Simmel e l'estetica. Arte, conoscenza e vita moderna. (2006), Platon in Diskurs (2006), (with Otthein Rammstedt) Georg Simmel Gesamtausgabe Bd. 16 (Der Krieg und die geistigen Entscheidungen, Individuum und Gesellschaft, Lebensanschauung, Der Konflikt der Kultur) 1999.



Stefano Catelani

He graduated in law at the University of Rome and took the Bar Exam in Italy in 1983 after two years of practice with a law firm in Florence. He then worked as chief counsel for more than five years for a major Italian pharmaceutical company before joining DuPont Legal in 1988. At DuPont over the years he has advised several subsidiaries and business units in the Europe, Middle East and Africa Region being based first in Italy and since 1990 at the European Headquarters in Geneva. In 1997, he moved to External Affairs where he worked as Director Governmental Affairs (Europe) before returning to Legal in 1999 to work as Corporate Counsel.

In this role he is now advising as general counsel several Strategic Business Units (SBUs) within the Europe, Middle East and Africa region and coordinates the work done in the countries by the local lawyers working for those SBUs. Stefano Catelani's current practice focuses on both general corporate and commercial law, taxation and mergers and acquisitions, including divestitures and joint ventures.

Issues relating to governance of both DuPont companies and joint ventures are part of Stefano Catelani's practice



Prof. Luisa Brunori

Her present position is Full Professor in the Department of Psychology, University of Bologna, part of the Faculty of Education. She is Professor of Dynamic Psychology, having specialized in Clinical Psychology in the Faculty of Medicine, followed by a specialization in Psychiatry. She is Director of CIRIG, the University of Bologna's Interdepartmental Centre for Research and Development of Group Psychotherapy, and founder and President of the University's M.I.O. (International Observatory for Microfinance). The Observatory's mission is to act as an international centre of excellence for research into and analysis of microfinance phenomena in a multidisciplinary perspective. She is affiliated to a number of professional societies, being inter alia a member of GAS (Group Analytic Society), London, and of the Board of Directors of IAGP (International Association of Group Psychotherapy). She is a member of, among others, the Editorial Board of "Group Analysis" and the Editorial Board of the review "Attachment and Human relations", London.



Christof Schwab

He graduated in Economics at the University of Regensburg, Germany.

Since 1998 he is working for Siemens, first for the AG as a Principal consultant in the CT Innovation Field Transportation, than as Vice President of Strategy&Partnering for Siemens Mobile Travel Solutions GmbH. In 2002 he changed to Siemens Mobile Phones, before occupying in 2004 the position of Director R&D Operational Support in Siemens Communications Mobile Devices. After a year spent in BenQ Mobile Group he turned back in Siemens AG. In his position of Manager Investor Relations he was responsible for the German and the Swiss market, the organisation of investor roadshows an presentation and the coordination of Social Responsible Investor Ratings (e.g. SAM, CDP). Since July 2009 Christof Schwab is Head of Equity Capital Markets and SRI. Among his major responsibilities: ECM Measure, SRI Presentations and Roadshows, AGM, Share Register.



Prof. Stefano Zamagni

He is Professor of Economics at the University of Bologna and Adjunct Professor of International Political Economy at Johns Hopkins University, Bologna Center. He is the author of numerous books and other publications (most recently Dizionario di Economia Civile (Dictionary of Civil Economics), with L. Bruni, Roma, Città Nuova, 2009). For his fine accomplishments, Professor Zamagni has been honored a number of times. In 2007 he was awarded the title of Knight Commander of the Order of St. Gregory the Great. Professor Zamagni was and is a member of a large number of Associations and Organizations. From 1999 to 2007 he was president of ICMC (an NGO based in Geneva dealing with migrant and refugee issues) and fellow of the "Human Development and Capability Association" (Harvard University). He was appointed (2007) President of the Italian Commission for the Non-Profit Sector, Milan. He is a member of the scientific committee of various economic journals and reviews. He was part of the working group that drafted the recent encyclical Caritas in veritate.
